tax purposes, even if you have no employees.

ESSENTIAL EQUIPMENT FOR YOUR LAWN MOWING STARTUP

As you grow, you may add a hedge

trimmer, pole saw, and a spreader for fertilizer or seed. Always maintain your equipment: sharpen blades, change oil, and keep filters clean. A breakdown on the job costs you money and reputation.

LEGAL REQUIREMENTS AND INSURANCE

Many newcomers skip this step, but it is essential. Check with your city or county for business licenses, permits, and zoning regulations. Some areas require a specific service license for lawn care. You may also need a sales tax permit if you sell services that are subject to tax (varies by state).

Insurance is critical. General liability insurance covers property damage and injuries to third parties. For example, if a rock from your trimmer cracks a window

or a customer trips over your hose, you need coverage. Policies for small lawn care businesses often cost \$300-\$600 per year. Some states also require workers' compensation insurance if you hire employees later.

Build a Strong Online Presence

Scheduling and Routing for Efficiency

Time is money in lawn mowing. Group your customers by geographic area to minimize driving time. For example, schedule all customers in the same subdivision on the same day. Communicate clearly with customers. Send a reminder text the day before, and let them know if you are running
