These documents define the scope of practice, standards of care, disciplinary processes, and the rights and responsibilities of nurses in the state. By passing the exam, you demonstrate to the BON that you are aware of the legal boundaries of your role and your obligation to protect public safety.

# Why Does the Texas BON Require This Exam?

The rationale behind the Texas Jurisprudence Exam Nursing requirement is straightforward: to protect the public. Every state has its own unique set of nursing laws, and Texas is no exception. The exam ensures that all nurses, whether educated in Texas or elsewhere, are on the same page regarding state-specific regulations. This includes understanding mandatory reporting

## WHO IS REQUIRED TO TAKE THE TEXAS JURISPRUDENCE EXAM?

Knowing whether you are required to sit for this exam is an important first step. The following groups of nurses must complete and pass the Texas Jurisprudence Exam Nursing component before receiving their license:

- **Graduate Nurses:** New graduates who have completed a nursing program and are applying

- **Licensed Vocational Nurses (LVNs):** Individuals seeking initial licensure as an LVN in Texas.
- **Registered Nurses (RNs):** RN applicants for initial licensure.

- **Nurses Reinstating a License:** Nurses who are applying to reinstate a lapsed or revoked Texas nursing license.

It is important to note that some nurses

may be exempt. For example, nurses who hold a valid multistate compact license and are practicing in Texas under that license do not need to take the Texas Jurisprudence Exam. However, if you change your state of residency to Texas, you will need to apply for a Texas single-state license and, in many cases, complete the exam.

### **KEY TOPICS COVERED ON THE TEXAS JURISPRUDENCE EXAM**

The exam is based entirely on the Texas Nursing Practice Act and the BON Rules and Regulations. You will not be tested on clinical pharmacology, pathophysiology, or nursing procedures. Instead, focus your study efforts on the following core areas:

# The Nursing Practice Act (NPA)

This is the foundational law that defines nursing in Texas. You need to understand the definitions of professional nursing, vocational nursing, and advanced practice registered nursing. Key sections include the scope of practice for each level of licensure, the requirements for licensure, and the grounds for denying, suspending, or revoking a license.

# Board of Nursing Rules and Regulations

These rules provide the detailed framework for the NPA. Important topics include:

- **Standards of Nursing Practice:** What constitutes acceptable and safe nursing care in Texas.
- **Delegation Rules:** The specific guidelines for RNs delegating tasks to LVNs and unlicensed assistive personnel. This is a heavily tested area.

## HOW TO REGISTER AND TAKE THE EXAM

---

The Texas Jurisprudence Exam Nursing process is managed entirely online through the Texas Board of Nursing website. Here is a step-by-step guide:

- Ensure your internet connection is stable before you begin.
- Have the Texas Nursing Practice Act and BON Rules open in a separate tab or as a printed document for quick reference.
- Read each question carefully. Many questions are based on specific wording from the law.
- Manage your time. Do not spend too long on any single question.

## COMMON CHALLENGES AND HOW

## TO OVERCOME THEM

Treat the exam with the same seriousness as any other licensure test. Even though you can look up answers, you need to know where to look and how to interpret what you find, which comes from preparation.

**PASS?**

---

Once you successfully complete the Texas Jurisprudence Exam Nursing requirement, your results are automatically forwarded to the Texas Board of Nursing. You do not need to submit a certificate or any additional paperwork. The BON will process your application and, provided all other requirements are met (such as background checks and NCLEX passing scores), your license will be issued.

If you are an out-of-state nurse applying by endorsement, passing the exam is often one of the final steps before your Texas license is approved. After you receive your license, remember that your knowledge of the NPA and BON

Rules is not just for the exam. It is a living document that should guide your daily practice. Staying informed about changes to the law is part of your ongoing professional responsibility.

## What If You Do Not Pass?

Failing the exam is not the end of the road. You are permitted to retake it after a waiting period, typically 24 hours. Use this time to review the areas where you

struggled. Focus on the NPA definitions and the delegation rules, as these are common stumbling blocks. Many nurses pass on their second attempt after a focused review. The key is to not give up and to use the experience as a learning opportunity.
